

PHOTO ID

At MDG, we may ask that you provide a valid, U.S. Government issued photo identification that is 100% legible, displaying your:

- (1) Full Name (First and Last Name)
- (2) Date of Birth

Types of acceptable photo IDs include:

- (a) Driver's License
- (b) Passport or Passport Card
- (c) Resident Card
- (d) State ID Card
- (e) Military ID Card


30+ DAY BANK STATEMENT

- (2) Up to Date Account Activity with Debit, Credit & Balance information




Questions About Banking?

 - a. If your bank statement doesn't have your full name and account number displayed on every page, you can submit a void cheque along with your statement. The void cheque should display both your full name and bank account number.





 - a. You can use a Direct Deposit Notification with the official ink stamp from your bank.



3. What if I have a joint-bank account with my spouse or another family member?
 - a. If you have a joint-bank account, both you and the other person who's on the bank account would need to submit their photo IDs with signatures.


