These measures include computer safeguards and secured files and buildings. We also maintain other physical, electronic and procedural safeguards to protect this information and we limit access to information to those employees for whom access is appropriate.
low does MDG USA Inc. collect my personal information?	 We collect your personal information, for example, when you: open an account or apply for financing give us your contact information or pay us by check give us your income information We also collect your personal information from others, such as credit bureaus, affiliates or other companies.
Why can't I limit all sharing?	 Federal law gives you the right to limit only: sharing for affiliates' everyday business purposes - information about your creditworthiness affiliates from using your information to market to you sharing for nonaffiliates to market to you State laws and individual companies may give you additional rights to limit sharing.
Definitions	
Affiliates	 Companies related by common ownership or control. They can be financial and nonfinancial companies. Our affiliates are financial and nonfinancial companies and include our companies that process order fulfillment and/or provide account servicing.
Nonaffiliates	 Companies not related by common ownership or control. They can be financial or nonfinancial companies. Nonaffiliates we share with can include banks, direct marketing companies and service providers.
Joint marketing	 A formal agreement between nonaffiliated financial companies that together market financial products or services to you. Our joint marketing partners include financial institutions.
